

"BurgerTime Delight" Sweepstakes

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Each text message sent or received, will incur a charge as provided in your rate plan, standard rates apply. Data charges may also be incurred.

1. Eligibility: The "BurgerTime Delight" Sweepstakes ("Sweepstakes") is open only to Sprint and Nextel subscribers as of 04/28/2008 who are legal residents of the fifty (50) United States (including District of Columbia) and who are at least eighteen (18) years old at the time of entry. Employees of Sprint Communications Company, L.P., Nextel, Namco Networks America Inc., Vibes Media, and their parent and affiliate companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and judge's decisions, which are final and binding in all matters related to the Sweepstakes. 4. How to Enter:

a. Purchase the BurgerTime Delight by Namco mobile game.

Accessing Sweepstakes on your Sprint or Nextel Handset: If you are a Sprint or Nextel service subscriber and have a data-capable phone, you can enter the Sweepstakes by accessing the WAP dedicated to the promotion and purchasing a copy of BurgerTime Delight.

You can access the WAP page in any of the following ways:

Click on 'Get BurgerTime Delight to Enter' or 'Download Now!' on the BurgerTime Delight WAP site for pricing information and the option to buy the game on your phone. You will not be charged for the game until you click 'Buy' on the purchase page. All entries per Sprint or Nextel device must be received by 11:59:59 p.m. CDT on June 9, 2008.

b. Enter for Free by mail: To enter without using a Sprint or Nextel data capable device, hand print your name, complete address (no P.O. Boxes), day and evening phone numbers, email address (if any), date of birth and "BurgerTime Delight" Sweepstakes on a 3" x 5" piece of paper and send it in a hand-addressed, stamped envelope, to "BurgerTime Delight" Sweepstakes c/o Vibes Media P.O. Box 3414, Chicago, IL 60654. All mail-in entries must be postmarked by June 9, 2008 and received by June 16, 2008 in order to be eligible.

All entries become the exclusive property of Sponsor, and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected text messaging entries/plays, which will be disqualified. In the event of a dispute as to any play/entry, the authorized account holder of the Sprint or Nextel phone used to register will be deemed to be the registrant or player. The "authorized account holder" of a Sprint or Nextel phone is the natural person in whose name the phone has been issued and the services are billed. Potential winners may be required to show proof of being the authorized account holder.

5. Drawings: Drawings will be conducted by an independent judging organization, from all eligible entries received during the Sweepstakes period on or around June 16, 2008. All decisions by the independent judging organization are final and binding in all matters related to the Sweepstakes.

6. Verification of Potential Winners: All potential sweepstakes winners are subject to verification by Sponsor or Administrator, whose decisions are final AND BINDING IN ALL MATTERS RELATED TO THE Sweepstakes. An entrant is not a winner of any prize unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete. Potential winners must continue to comply with all terms and a condition of these Official Rules and winning is contingent upon fulfilling all requirements. The potential Grand Prize Sweepstakes winners will be notified by phone, registered mail and/or text message. Three (3) attempts to contact the potential Grand Prize winners will be made within 48 hours from the time winner selection was accomplished. If the Administrator is unable to reach potential Grand Prize winners via phone within this time frame, the applicable potential winner will be disqualified and alternates will be selected.

If a potential winner cannot be contacted, or fails to sign and return the affidavit of eligibility and liability/publicity release within the required time period (if applicable), potential winner forfeits prize. In the event that a potential winner is disqualified for any reason, the applicable prize will be awarded to an alternate winner by random drawing from among all remaining eligible entries.

7. PRIZES: Grand Prize (2): Two winners will receive \$1,000 worth of gift certificates to a nation wide burger restaurant of his/her choice. The total value of all prizes is \$2000.

Sponsor reserves the right to substitute any listed prize or prize component for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use and all other incidentals not included above in the prize package. Sponsor will cover shipping and handling costs. Odds of winning a Sweepstakes prize depends on the number of eligible entries received during the Sweepstakes Period.

8. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other Promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the state of California (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsors in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California.
